“O” Show Grant Application

This form must be completed and submitted at least 30 days prior to the show start date for consideration. Any shows applying for the grant must be held in the state of Oklahoma. All “O” shows must meet the minimum requirements for an “O” rating as stated in the OHJA Bylaws. If show management is found in violation of meeting the minimum requirements during the show, the grant money must be returned to OHJA and management will not be eligible to apply for any “O” show grants within the next 12 months.

The grant applications will be carefully considered by an appointed impartial committee comprised of OHJA board members and approved by the Board of Directors. Provided funds are available, grants will be awarded in amounts up to \$500 based on the quality of offerings at the show and each show owner will be allowed two show grants per show year. Show management will be notified within 14 days of the committee’s decision and will be awarded the grant no later than the final day of the show. In order to be eligible for a grant, the entire show (from Leadline to Rated divisions) must meet the “O” Show minimum requirements.

“O” Show Minimum Requirements (Check all that apply)

- Offer 4 Rated divisions that follow USEF national or zone specifications.
- USEF licensed judges – with the exception of classes 18” or lower.
- Offer the OHJA 3’ Medal.
- Designate a show steward that is a USEF member in good standing, who has proficient knowledge of the USEF rules.
- Show Manager is a member of OHJA.
- Obtain liability insurance naming OHJA as additional insured.
- Must have cones/markers/timers to denote start/stop line for all jumper courses.
- Any pony or horse competing in a division that requires a measurement card must have a USEF measurement card as proof or a signed document from a licensed veterinarian. (This would allow exhibitors a chance to show in a height section without needing to have previously shown in a USEF rated show).

“O” Show Optional Specifications (Please check all that apply)

Base amount for local barn show - \$100 maxing out at \$500 with variables below.

Base amount for non-boarding rented facility (Expo Centers/Fairgrounds) – \$250 maxing out at \$500 with variables below.

- USEF licensed course designer. Grant value = \$150.
- USEF licensed show steward. Grant value = \$50.
- Automatic timers for the jumper divisions. Grant value = \$50.
- Handy classes within the hunter divisions. Grant value = \$25.
- At least 50% of obstacles in the jumper courses include true “jumper” type obstacles, i.e. Liverpool, striped rails, planks, triple bar, fan jump, flat cups, etc. Grant value = \$25.
- Numbered and flagged jumps for the jumper division. Grant value = \$25.
- FEI, safety approved quick release cups on the back rails of oxers. Grant value = \$50.
- Licensed vet available on site or on call with written agreement for duration of show. Grant value = \$10.
- Licensed farrier available on site or on call with written agreement for duration of show. Grant value = \$10.
- Separate lunging area. Grant value = \$25.
- USEF drug and medication rules pamphlets available in the show office. Grant value = \$10.
- SafeSport and microchipping information available to exhibitors in the show office. Grant value = \$10.
- USHJA town hall meeting or “Ask the Judge” session. Grant value = \$25.

Presentation from a professional within the horse industry (vet, farrier, saddle fitter, etc.).
Grant value = \$10.
